

Robins Air Force Base Economic Impact Statement



Robins has \$4.263 billion economic impact on Georgia

obins Air Force Base contributes \$4.263 billion to the Georgia economy, according to the installation's latest economic impact statement. That represents a 10.6% increase in overall impact from the previous year.

Published annually, the statement provides general information about the economic impact the installation has on the state of Georgia.

The report is also distributed to federal, state and local officials.

The fiscal 2024 statement sizes Robins' workforce at 22,387 – a figure that is made up of 14,788 appropriated fund civilians, 5,091 military members and 2,508 other employees, including contract and non-appropriated fund employees.

The statement also says Robins paid out \$1.74 billion in salaries. The largest chunk of that money – \$1.30 billion – went to civilians working on base, while military members accounted for \$422 million. Nonappropriated fund employees accounted for just over \$19 million.

Additionally, the base awarded \$6.78 billion in contracts during fiscal 2024. In Georgia, the base awarded \$585.6 million. Of that amount , Georgia firms in Houston and Bibb Counties accounted for 33% or \$192.6 million.

The analysis also showed the base's utility costs increased by \$3.79 million.

This fiscal year, our financial analysis focuses on dollar-based expenditures, or dollars spent, within a 50 mile radius of Robins Air Force Base. According to Robins AFB financial experts, this methodology provides an accurate description of the installation's regional impact.


