

DISTRACTED DRIVING

Distracted driving is any activity that diverts a vehicle operators attention away from the main task of driving. Distractors include texting, cell phone use, eating, grooming, reading, etc. The best way to end distracted driving is to educate all personnel on the associated danger.

MISCELLANAEOUS

Cell phone use is prohibited while driving without a roper hands-free device. Base security forces are responsible for enforcing speed limits and all other traffic laws. All state and local driving laws are applicable on base. Violations of traffic laws can be reported to the 78th Security Forces Law Enforcement Desk in Building 263, 926-2187.

Smoking on Robins AFB is only allow in designated tobacco areas.

Balance boards or hover boards are only authorized for use in the military family housing and dormitory areas by residents. A helmet is required while operating hover boards or balance boards in those areas.

Wearing of portable headphones, earbuds, or other listening devices is prohibited while operating a motor vehicle (with the exception of a hands free cell phone device). The use of these devices are also prohibited while jogging/running, bicycling, skating or skate boarding on installation roads/streets.

Riding a bicycle to work or just for exercise and pleasure, you must wear a helmet and ride on the same side of the road with vehicular traffic. Riding a bicycle on sidewalks is prohibited. Wearing reflective outer garments during periods of reduced visibility is highly encouraged.

Welcome to Robins AFB. As the largest industrial complex in the state of Georgia the safety of each individual is our priority. This pamphlet provides you with local information to ensure you stay safe while on the installation and travelling in the surrounding area.

TRAFFIC SAFETY

Approximately 20,000 employees commute to the base each day through 4 gates. Therefore, you can expect some delay when travelling on and off base during certain peak periods. The speed limit on Robins AFB ranges from 15—35 MPH. The use of seatbelts are mandatory for all vehicle occupants equipped with restraining devices. It is illegal for a vehicle operator to use a cellular phone while driving unless equipped with hands-free technology. Texting and driving is illegal on Robins AFB and the state of Georgia.

As you travel across the installation, be mindful of Low Speed Vehicles (LSVs) such as industrial carts, forklifts, tugs, etc. LSVs are restricted from travelling certain high traffic sections of the installation. During certain times of the day, a high volume of pedestrian traffic can be seen along areas of the installation that house a large number of administrative functions. Pedestrians should remain vigilant at all times, while vehicle operators should remember pedestrians have the right of way while in a crosswalk.

There are a few Georgia State Laws that you need to know. Georgia's Move-Over Law is meant to keep police officers, emergency rescue vehicles and utility vehicles safe from passing cars. This law requires vehicle operators to move-over a lane for emergency vehicles stopped on the side of the highway. The Georgia Super Speeder Law is designed to crack down on high-risk drivers who endanger others. Drivers can be fined an additional \$200 state fee if convicted of driving 75 MPH or more on any two lane road, or traveling 85 MPH and over anywhere in Georgia.

MOTORCYCLE SAFETY

The 78 ABW Safety Office manages the installation motorcycle safety program. AFI 91-207 requires personal protective equipment (PPE) in the form of proper head (DOT approved helmet), eye (ANSI approved goggles, wrap around glasses or a full face shield attached to the helmet) foot (sturdy over the ankle footwear) and full finger hand protection to be worn. Riders are also required to wear a long sleeved shirt or jacket and trousers. Though not mandatory, riders should select PPE that incorporates fluorescent colors and retro-reflective material. Active duty military riders are required to maintain a Motorcycle Unit Safety Training Tool account. Specific training requirements for active duty members to operate a motorcycle are defined in AFI 91-207, Table 4. Civilian riders require a state drivers license with an M endorsement and follow all PPE requirements. Contact your unit motorcycle safety monitor or 78 ABW/SE for assistance.

LOCAL WILDLIFE AND ENVIRONMENT

Robins AFB property consists of approximately 6,900 acres. On our property you will find wildlife such as bears, wild hogs, deer, fox, beavers, geese, etc. Various types of venomous snakes (i.e. copper head, water moccasin and timber rattle snakes) also roam our woods. Hunting and fishing are allowed at designated locations on the installation during certain times of the year. In addition to the Georgia hunting or fishing license, a Robins AFB license is also required. Contact 78 FSS at **(478) 926-4001** for further guidance.

5K AND OTHER TRAILS

Follow these safety tips: Be vigilant and aware of your surroundings at all times. Carry your cell phone for emergency use. Always travel with at least with one other person. Avoid traveling on the trails during the hours of darkness. Let a friend or family member know where you will be going, the route you will be traveling and the time they can expect you home. Ensure your carry water for yourself and your pets. If you see or suspect suspicious activity, please call Security Forces at **(478) 926-2187**.

HEAT STRESS

It is not uncommon for temperatures in our local area to exceed 100 degrees Fahrenheit during our peak summer months (normally July—August). The high heat temperatures coupled with extreme humidity can pose potential heat stress injuries to some. During the peak summer months, Local heat index conditions are monitored throughout the day, along with recommended work-rest cycles. Proper hydration and resting in the shade or in an air-conditioned area will help reduce the potential health effects from heat stress.

HAZARD REPORTING

Since your safety is our primary concern, we encourage the timely reporting of hazards you may identify on the installation. Immediately notify your supervisor of any hazards in your workplace for corrective action. You can contact your facility managers to address safety concerns in the building where you work. You can also submit a completed AF Form 457 (Hazard Report) to 78 ABW/SE to report any safety issues or concerns. The Robins Hazard Reporting Tool (HRT) serves as an electronic equivalent to the AF Form 457. Access to the Robins HRT icon is available on every network computer desktop.



MISHAP REPORTING

Military & civilian personnel must immediately notify their supervisor of all on-duty mishaps. Military members are also required to report all off-duty mishaps. Supervisors must encourage injured personnel to seek medical attention and initiate an AF Form 978 (Supervisor's Mishap Report). In accordance with AFMAN 91-224, the completed mishap report (coordinated and reviewed by the unit safety representative and commander) must be turned in to the 78 ABW/SE or your respective safety office within 5 days of notification.
