# Work in Progress

Maintenance pros begin Global Hawk paint mission



**M**aintenance pros at the Warner Robins Air Logistics complex have begun work on the RO-4 Global Hawk that recently made history by being the first to fly into an air logistics complex.

Robins will provide an organic paint capability. This work is necessary to prevent corrosion and deterioration of the aircraft to keep it operating at full mission performance. Plus, the establishment of a Building Based Launch and Recovery Element will allow for launch, landing and ground recovery operations of the aircraft.

While a PDM requirement for Global Hawk has not been established, the Air Force recognizes that having an organic maintenance capability for Global Hawk enhances our ability to manage the fleet and keep this resource flying.

# End of an Era

**A**lthough the 78<sup>th</sup> Medical Group Dental Squadron inactivated June 2, services available to active duty members at Robins will remain the same.

The Dental Clinic, which has been in existence since 1994, has transitioned from a squadron to a flight and realigned under the Aerospace Medical Squadron due to changes in the active duty population at the base.

Providing dental services that keep active duty members at Robins ready for deployment is the vital mission of the clinic.

**"Our mission is strong when it comes to readiness,"** said Lt. Col. Rene Saenz, 78<sup>th</sup> DS outgoing commander.

While the readiness rate goal of the Air Force is 95 percent, the 78<sup>th</sup> DS has consistently maintained a 98 percent rate. Any member not ready to deploy at any given moment is routinely taken care of within 30 days.

The mission of the squadron has not become any less important, and as a flight its personnel will continue providing exceptional levels of readiness and customer satisfaction.

Because the number of activity duty service members at Robins has gone down over the years, not as many personnel are needed to accomplish the mission. That's the primary reason the clinic, which only services active duty members, has been reduced from 45 personnel to 29.

**"We service 800 to 1,000 appointments monthly,"** said Saenz. **"That's down about 10 to 20 percent."**

An inactivation ceremony attended by nearly 100 guests was held at Hangar One of the Museum of Aviation to commemorate the historic occasion. The presiding officer for the event was Col. Christine Berberick, 78<sup>th</sup> MDG commander.

The guidon flag passed to Berberick by the outgoing commander was furled and cased for transportation to the Air Force Museum of History at Wright Patterson Air Force Base, Ohio, where it will be archived.

The newly established flight will be led by Maj. Michael Alfaro, who will arrive at Robins from Moody Air Force Base, Georgia, early in July.

Upon marking history as the last 78<sup>th</sup> DS commander, Saenz is headed to San Antonio, Texas, to serve in a headquarters staff position for the Air Force Medical Operations Agency.

# FAIL TO STOP, WALK TO WORK

Failing to stop at the gates or following Security Forces directions, can lead to the security gates being triggered, which can sometimes lead to unintended consequences like damage to vehicles.

**T**hinking about driving through the gate without stopping? Think again.

Failing to stop or follow directions of Security Forces personnel at the Robins' installation entry control gates will now result in an automatic 30-day suspension of base driving privileges.

Col. Jeff King, the 78th Air Base Wing and Robins Air Force Base installation commander, directed the change to the base driving instruction in mid-May.

The updated traffic guidance addresses incidents in which individuals fail to stop at the gate or ignore the directions of security forces and continue on into the installation.

The driving suspension applies to all individuals – regardless of status.

If base driving privileges are suspended, employees would not be permitted to operate a privately owned or government vehicle on Robins Air Force Base.

Keep Calm and Airman On.  
It's a catch phrase posted

nearly all over Robins Air Force Base that embodies the message of resiliency.

Team Robins Frontline Supervisor Symposium **"Helping You Manage Your Organization's Most Valuable Resource -- Employees"** is an optional class that will be offered upon request to each base organization from May until the end of August.

Tandra Hunter, a Violence Prevention specialist at Robins, said the training will educate supervisors on community helping agencies, suicide prevention efforts, and the Green Dot program giving them tools to help their workers be resilient in the face of work and life challenges.

**"One of the training objectives is to describe the relationship between leadership, supervisors and employees as it relates to prevention,"** she said. **"This training will help to increase the knowledge of the Integrated Delivery System and enhance resilience efforts. It will help frontline supervisors to recognize how an integrated system of services can help to create positive health outcomes for them and their employees."**

Col. Jeff King, 78<sup>th</sup> Air Base Wing commander, said the course prepares supervisors to help their own.

**"Resiliency is not only important in our personal lives, but it's also vital to**

**mission success,"** he said. **"Now, our leaders will be well versed on the programs we have to help our Airmen – military and civilian – Keep Calm and Airman On. Instead of 'one-size-fits-all' mass training, we can provide commanders with a collection of resources from which they can draw to address unit-specific issues and trends identified through DEOCS reports and other command climate indicators."**

Col. Sarah Christ, 78th ABW vice commander said the training will posture supervisors to be proactive before crises arise.

**"If you notice an Airman, whether military or civilian, is having a hard time or something is different about the person's demeanor, this training will give the supervisor the knowledge needed to head-off a budding problem before it's too late."**

Hunter said the new class will credit supervisors for Green Dot training and will give them more effective ways of handling employee crisis situations.

**"It's a one stop shop where they get credit for the required training and additional tools needed to handle tough situations in the workplace,"** she said. **"This training is optional for frontline supervisors, but it's a great benefit for the organizations on our base."**

Hunter said frontline supervisors play an important role in organizations.

**"This training will help new supervisors as well as seasoned supervisors to excel,"** she said. **"This will give unit leaders a tool to be peer influencers, and it will provide them with resources from our base helping agencies to better manage behavioral risk. Supervisors will walk away with a better understanding of how all of these programs work together to ensure a 'ready and resilient' force."**

# CONTRACTING ASSOCIATION PROGRAM PROVIDES OPEN DIALOGUE WITH BASE LEADERSHIP

The Middle Georgia National Contract Management Association Chapter has been reenergizing its acquisition information footprint in the local community.

Recently, the association hosted its May 2017 program which included Robins Complex senior leaders Donna Frazier, 402nd Maintenance Support Group director, and Col. Jason Edelblute, 402nd Electronic Maintenance Group commander.

The May program was facilitated by Mary Nauss, NCMA vice-president.

A list of “prime-the-pump” questions generated open dialogue between the panel members and the audience regarding the Depot’s commitments to the highly successful Art of the Possible initiatives, and direct dialogue concerning perceptions of contracting from a strategic and tactical level in terms of the value it serves to the depot mission.

Frazier said Robins Air Force Base’s depot has been fundamental in implementing Art of the Possible, noting a 40 percent decrease regarding work in process for the Maintenance Acquisition Program Office, led by Jimmy Katsekis, Air Force Materiel Command Acquisition Support Branch chief.

Edelblute discussed how important it is to have senior-level, cross-functionary communication to eliminate barriers by using the AoP with the Air Force Supply Chain, Program Office and Defense Logistics Agency.

These partnerships help ensure that EMXG maintainers receive the parts they need in a timely fashion.

He also said that internal part request data has been better controlled as a result of the AoP implementation.

Frazier said she considered integrity to be the most valuable trait depot leaders found in warranted contracting officers. Edelblute said he looked to contracting officers as the overall acquisition business advisors.

Robins Senior contracting leaders in attendance included Col. Anna Morris, Contracting acting director, Micki Cranford, Systems Support Contracting Division chief and June Nelson, Contracting technical director.

# Levy: Flag represents national identity, ideals

*Every year June 14 is a special, nationally recognized day to honor our flag, which remains an enduring symbol of hope, liberty and freedom.*

*On June 14, 1777, the Continental Congress adopted a resolution establishing the United States flag as having 13 stripes alternating between seven red and six white; and that the union be 13 stars, white in a blue field representing a new constellation. Our flag has since added more stars, but remains the enduring symbol of liberty and freedom it has always been for our Nation. The 13 horizontal stripes represent the original 13 colonies, while the stars represent the 50 states of the Union. The colors of the flag are symbolic as well: red symbolizes hardiness and valor, white signifies purity and innocence, and blue represents vigilance, perseverance and justice.*

*Flag Day observances were initially held at a local or state level until the first nationally recognized Flag Day occurred in 1916 by proclamation of President Woodrow Wilson. While Flag Day celebrations continued in various communities after the proclamation, in 1949 President Truman signed an Act of Congress officially designating 14 June of each year as National Flag Day.*

*Our flag represents our national identity and ideals, and remains a banner of freedom that unites us all. It continues to carry the message of freedom and inspiration to Americans at home and abroad.*

*Thank you for all that you do for our Air Force and our Nation. Your contribution in the Air Force Sustainment Center is vital in delivering combat power for the warfighter. As always, I am proud to serve alongside you.*

# Military Justice

The following airman was found guilty at a general court-martial:  
February 2017

A 461st Air Control Wing Airman First Class was found guilty by members of one charge and one specification of premeditated murder, and one charge and one specification of the death of an unborn child. The member was sentenced to life in confinement without the possibility of parole, a reduction to E-1, total forfeitures and a dishonorable discharge.

The following airmen received nonjudicial punishment in accordance with Article 15, Uniform Code of Military Justice (UCMJ), and AFI 51-202:

January 2017

- A 461st Air Control Wing officer made a false official statement regarding transportation on a TDY, and fraudulently submitted a false travel voucher. The commander issued a forfeiture of \$612 pay per month for two months, suspending the portion of the forfeitures in excess of \$200 pay per month for two months and reprimanded the member.
- Another 461st Air Control Wing officer made a false official statement regarding transportation on a TDY, and fraudulently submitted a false travel voucher. The commander issued a forfeiture of \$612 pay per month for two months, suspending the portion of the forfeitures in excess of \$200 pay per month for two months and reprimanded the member.
- A 78th Air Base Wing airman failed to report to duty twice. The commander reduced the airman to the rank of airman basic, suspended a forfeiture of \$799 pay per month for two months and reprimanded the member.
- A 461st Air Control Wing senior airman failed to report to duty, and made two false official statements. One statement included signing an AF Form 4446 the member knew to be false. **The commander suspended the member's reduction to airman first class, issued a forfeiture of pay for one month and reprimanded the member.**
- A 461st Air Control Wing senior airman failed to report to duty multiple times, and falsified an official record, specifically an AF IMT 1975. The commander reduced the member to Airman First Class and reprimanded the member.
- A 78th Air Base Wing senior airman was derelict in the performance of duty by failing to process required paperwork, and made a false official statement with regards to the dereliction of duty. The commander reduced the member to airman first class and reprimanded the member.

February 2017

- A 461st Air Control Wing senior airman wrongfully used methamphetamine and methylphenidate on multiple occasions. The commander reduced the member to airman first class and reprimanded the member.
- A 78th Air Base Wing senior airman made three false official statements. One statement included providing a certificate the member knew to be false. **The commander suspended the member's reduction to airman first class, issued a forfeiture of \$306 pay for two months, seven days extra duty and reprimanded the member.**

March 2017

- A 5th Combat Communications Group airman first class communicated indecent language to a child under the age of 16 years, and wrongfully possessed child pornography. Because the family refused to cooperate, the member was reduced to airman basic, reprimanded and discharged.
- A 461st Air Control Wing airman first class failed to report to duty multiple times, and falsified an official record, specifically an AF IMT 1975. The commander reduced the member to Airman Basic and reprimanded the member.
- A 78th Air Base Wing senior airman left a place of duty without authorization and was derelict in performance of duty by failing to maintain control of an assigned item. The commander reduced the member to airman first class and reprimanded the member.
- A 78th Air Base Wing senior airman was derelict in the performance of duty by failing to follow a relevant Air Force Instruction. The commander issued a forfeiture of \$307 pay per month for two months, 14 days extra duty and reprimanded the member.

April 2017

- A 78th Air Base Wing senior airman was derelict in the performance of duty by failing to file a required report, and made two false official statements regarding the dereliction. **The commander suspended the member's reduction to airman first class and reprimanded the member.**

# Georgia issues new permit for industrial stormwater

**T**he Georgia Environmental Protection Division has recently issued an update to the permit for stormwater discharges associated with industrial activities.

This permit is one of several which the base must comply with under the National Pollutant Discharge Elimination System or NPDES.

The NPDES program was developed to reduce and eliminate the release of toxic substances in stormwater runoff into downstream waterbodies.

The base is required to be covered under this updated Industrial Stormwater General Permit for stormwater discharges from areas associated with activities such as aircraft operations and maintenance, aircraft painting and depainting, vehicle maintenance, fueling, chemical loading and storage, and storage of recyclable materials.

**There are numerous changes from the previous version of the permit. Some of the key changes that directly affect the base include:**

- *Making sure that the lids on dumpsters are maintained closed to prevent rainwater from accumulating;*
- *Ensuring that storm drains have minimal debris and sediment accumulation;*
- *An increased focus on maintaining areas of the Base prone to erosion (sediment discharges into our water bodies is one of the largest causes of stormwater pollution in the United States);*
- *Increased requirements associated with tracking of corrective actions when items are identified that are not in compliance with the permit (e.g., leaking equipment);*
- *Expanding the number of people who must be trained annually on the permit requirements; and*
- *Sampling of stormwater for oil and grease and total suspended solids in select areas of the base that conduct vehicle maintenance or equipment cleaning operations.*

The 2017 Industrial Stormwater General Permit became effective on June 1.

The base is in the process of updating the facility's Stormwater Pollution Prevention Plan to comply with the new permit requirements. The SWPPP identifies potential sources of stormwater pollution; describes control measures used to reduce pollutants in stormwater discharges; and details the methods used to implement the control measures.

Updates to the SWPPP are required to be completed by Aug. 30, 2017, and full implementation of the new requirements must begin by Nov. 28, 2017.
