





If F²AST or SbAST is being considered:

- ➤ Call or email AFSC/PZIE-R
 - Advise of your potential requirement
 - Provide PWS and Market Research if available
- ➤ Meet with AFSC/PZIE-R
 - Via e-mail, phone, or face-to-face
 - Not limited to one meeting
 - Review requirements documents
 - Prepare the F²AST/SbAST checklist
 - Early coordination with the Small Business Office is recommended



F²AST/SbAST Process (cont.)



- ➤ Develop the PR Package
 - PR, PWS, Performance Plan, RAD, F²AST/SbAST checklist etc.
- ➤ CO Issues Request for Order Proposal (RFOP)
 - F²AST PCO will issue for centralized orders
 - All applicable clauses are included
 - The official RFOP will not be released until a <u>complete</u> package is received in R2M
 - -A control number must be assigned by AFSC/PZIE-R



F²AST/SbAST Process (cont.)

≻Evaluation of Offerors

- Tech evaluation conducted by requiring activity
- Cost/Price evaluation conducted by AFSC/PZIE-R for centralized orders
- ➤ Delivery/Task Order (D/TO) Award
 - AFSC/PZIE-R PCO in conjunction with requiring activity's team makes a best value decision
- **≻**Administration
 - Performed by Requirements PCO for D/TO(s)



F²AST/SbAST Protests



Warner Robins Air Logistics Complex

▶Protest of Orders

- Contractors can protest D/TOs based on:
 - Order increases scope, period of performance, or maximum value of the order
 - Orders over \$10M (FAR 16.505(a)(9)(i))
- AFSC/PZIE-R PCO will respond to protests resulting from award process disputes
- Requiring activity PCO will respond to protests resulting from scope, performance, or acquisition strategy






DESP III Small Business Set-Aside Process

- Step 1: Conduct Market Research and coordinate with the Small Business Office
- Step 2: Develop DESP III Requirements Package
- Step 3: Conduct a Request for Information (Small Business Determination)
- Step 4: Review and Coordinate DESP III Requirements Package
- Step 5: Schedule and Support TORB
- Step 6: Finalize DESP III Requirements Package and Conduct Industry Day where

possible

- Step 7: DESP III TL Signs PR Supplement Sheets and RFP is Released
- Step 8: M3 Evaluation of Task Order Proposals
- Step 9: Task Order Award, Management, and Close-out
