New citation policy aims to reduce traffic risks

A new type of traffic citation for moving violations is now being used at Robins.

A driver who breaks the rules here now receives a citation similar to those issued by any law enforcement agency in the local area.

Robins has never been a safe haven for violators of traffic laws; rules for off-base moving violations have always been enforced on base. The main difference is violators now will receive a notice to appear in U.S. Magistrate Court in Macon and could face monetary fines.

Similar citations are used at many Air Force and Army installations across the country,

and they're being used at Robins to help make the community safer.

State traffic laws are enforced on base by security forces personnel, who are trained to recognize and respond to moving violations, including speeding, driving recklessly, following too closely, failure to yield, and seat belt and child restraint violations. Among other things, they also enforce the base instruction prosecutable in Magistrate Court — which prohibits the use of handheld cell phones and other communication devices while operating a motor vehi-

The new citations are processed through a Central Violations Bureau.

If you receive a citation, you may pay the fine through the CVB and avoid the court appearance. Instructions on the back of the citation will show you how to contact the CVB. Funds paid by violators are not received by Robins, but deposited through the CVB into the U.S. Treasury.

If you wish to dispute the citation, your case will be referred to the U.S. Magistrate Court of Middle Georgia.

DLA expands presence at Robins

It's a rare occasion when a Navy vice admiral comes to Robins, but Feb. 25 was a special day.

Vice Admiral Alan S. Thompson, Defense Logistics Agency director, came here to cut the ribbon on a new \$24.6 million consolidation and containerization point warehouse.

The opening of the building, about the size of three football fields, is the result of a decision by the 2005 Base Realignment and Closure Commission to base one of DLA's four strategic distribution points at Robins.

DLA Robins has been growing rapidly, from 100 employees when it started operations here in 2007, to 900 today. The organization ships supplies to Army, Navy, Air Force and Marine

One Base, One Network

Computer system upgrade project to begin next month

A major project to upgrade Robins' vast computer network will begin in a few weeks.

After months of planning, the installation of a high bandwidth network is slated to begin immediately following a kickoff meeting April 26.

The Air Force-mandated Combat Information System One Base One Network Project will link employees in 260 core buildings here. The \$15 million project will impact all users on the Robins.mil and ANG.mil networks.

Installation will take a year and involve laying 36 miles of fiber optic cable and 21 miles of conduit. It will also include installing 1,126 new network

"Basically, we are going to have a more reliable network," said Roger Vann, communications planner for the 78th Air Base Wing Communications Directorate.

AF a Green Power Partner leader

The Air Force is one of the nation's top purchasers of green power, according to the U.S. Environmental Protection Agency's Top 25 list of Green Power Partners released this

The Air Force is being recognized for its purchase and on-site production of 243.9 million kilowatt-hours of green power from U.S. renewable facilities built after 1997. The Air Force use of renewable energy ranks number one in the Department of Defense, number two in the federal government, and number 15 among 1,300 Green Power Partners including large corporations and municipalities such as Dallas and Houston. In addition, Air Force officials purchased 250 million kilowatt-hours of renewable energy from facilities built before 1997 for a total renewable usage of 493.9



million kilowatt-hours.

The EPA Green Power program only gives credit to renewable energy produced at U.S. facilities built after 1997.

"Green power" is defined by the partnership as electricity that is partially or entirely generated from environmentally preferable resources, such as solar, wind, geothermal, biogas, and low-impact biomass and hydro

"The use of 243.9 million kilowatthours of green power is comparable to

Safeguarding information

A major news story in recent months has been the unauthorized release of classified information via the internet.

Guidance released by the Under Secretary of Defense on Jan. 11 states "the recent disclosure of U.S. Government documents has caused damage to our national security. Classified information, whether or not already posted on public websites or disclosed to the media, remains classified and must be treated as such until it is declassified by an appropriate U.S. Government Authority."

It goes on to state, "it is the responsibility of every DOD employee and contractor to protect classified information and to follow established procedures for accessing classified information only through authorized means."

The Office of the Secretary of the Air Force has issued additional guidance stat-



ing, "every employee has an obligation to protect classified information and the integrity of the government IT systems, and unauthorized classified information disclosures, no matter where or in what format the information resides, does not change the classification of the information."

Robins personnel should not access and view Web sites containing classified information without authorization. Michael Harnage, 78th Air Base Wing Information Protection Director, suggests personnel contact their unit security manager if they have any questions regarding the proper security classification of information.

CE team aids Kirtland following deep freeze

A team of 78th Civil Engineer Group plumbers recently returned from a lengthy service call to aid another base in need.

The five-man team spent two weeks helping Kirtland Air Force Base in New Mexico recover from extensive damage caused by a rare deep freeze. The base suffered so many busted pipes it had to call in some outside help to get many buildings operational again.

The team left for Kirtland Feb. 6 and returned Feb. 17. When they departed, the most significant damage had been repaired and the base was fully functional again, said Ricky Tidwell, who led the team.

Teams from Edwards AFB, Calif., Wright-Patterson AFB, Ohio, and Eglin AFB, Fla., also answered the call for help. Kirtland officials were very appreciative of their efforts, Tidwell said.

"They said we did in two weeks what would have taken months if they had just stuck with what they had," Tidwell said. "It was pretty wide-scale destruction."

The team put in 10-11 hour days in

weather which was still very cold for the first few days, with snow still on the ground. The area was hit with a winter storm in which temperatures reached 20 below – far colder than what the buildings were designed to withstand.

The Robins team spent much of its time working in hangars on the fire suppression system, along with other broken water pipes. They also spent two days replacing a 20-inch underground gate valve.

With the entire area similarly struck and supplies scarce, Tidwell said Kirtland did a good job of giving the team everything it needed.

"Everything went extremely well,"

Tidwell said. "They had everything lined up for us, and their people did a good job of getting us parts."

Other members of the team were Joel

Kersey, Thomas McDaniel, Terry Owens, and John Bennett.

Danny Hale, utilities branch chief at Kirtland, said in an e-mail he was very appreciative of the help.

"They all showed a willingness to do whatever was asked of them," he said. "They showed up early every morning and worked hard every day."

removing greenhouse gas emissions of nearly 33,497 cars or 21,261 homes a year," said Dick Fillman, an engineer who focuses on renewable energy at the Air Force Facility Energy Center, located at the Air Force Civil Engineer Support Agency at Tyndall Air Force Base, Fla.

Air Force officials purchased less green power in 2010 than in years past, which actually signifies a step forward due to more renewable energy generation capacity on Air Force bases.

"In an ideal situation, we'd prefer to produce all renewable energy on-base eliminating the need to purchase it on the open market," said Rick Stacey, AFFEC director, "but we're not there yet."

The Air Force Infrastructure

Energy Implementation Plan includes a three-tiered approach for achieving renewable energy goals. First, develop on-site renewable energy resources to the extent economically and technically feasible. Second, procure renewable power from off-site resources delivered over the power grid; and third, purchase renewable energy certificates if the renewable energy from onbase projects and commercial purchases falls short of the annual Air Force goal.

More than 6 percent of all facility energy used by the Air Force comes from green power sources which is more than the federally mandated renewable-energy goal of 5 percent by 2010.

In 2015, renewable energy is expected to make up more than 10 percent of all electricity used by the Air Force. Examples of Air Force renewable energy projects include: 14.2 megawatt photovoltaic solar array at Nellis AFB, Nev.; one megawatt photovoltaic solar array at Buckley AFB, Colo.; 388 kilowatt photovoltaic thinfilm integrated membrane roof on the base exchange at Luke AFB, Ariz.; 2.3 megawatt landfill gas generator at Hill AFB, Utah; 3.32 megawatt wind generation at F.E. Warren AFB, Wyo.; 400 kilowatt roof photovoltaic system at Los Angeles AFB, Calif.; 660 kilowatt photovoltaic at Fresno Air National Guard Base, Calif.; 500 kilowatt photovoltaic at Toledo ANGB, Ohio; and a 250 kilowatt wind generator at Tin City Long Range Radar Site, Alaska.

Air Force officials also plan to award contracts for wind and waste-to-energy projects this year.

Federal mandates require that 25 percent of Air Force facility energy use come from renewable energy sources by 2025.

installations throughout the Southeast and around the world.

As a strategic distribution point, it will also be shipping supplies directly to the warfighter. As he spoke to those gathered for the ribbon cutting, Thompson pointed out pallets with supplydrop parachutes behind him


which will soon be headed for Afghanistan.

"This is a marvelous facility; it will support global operations of the U.S. armed forces," he said. "It's going to add great new capability and capacity for DLA, and we are going to be using it immediately."

Thompson cut the ribbon as other DLA and Robins officials stood alongside him, with DLA ground.

The operation will mean approximately 25-30 additional trucks per day coming onto the base, bringing in items from hundreds of manufacturers around the country.

The items will be prepared for shipping here and then trucked to the port of Savannah, and aerial ports in Charleston, S.C., and Dover, Del., among other loca-

Reveille and Retreat: Proper observance

Editor's note: Due to an editorial error last week, we are rerunning this article, which includes additional information for clarification on Reveille in the morning as well as the designated location of the installation flag.

As the command chief, I receive a lot of questions about Retreat, and I witness a fair amount of instances where people don't observe or exercise the proper customs and courtesies. If people know what they're supposed to do and understand why we do it, as well as how important it is to us, they'll willingly follow suit. If they're still not so inclined to do so, I would respectfully remind them we work on a military installation; therefore, we are required



to adhere. For me, it's no different than being a guest in someone else's home. While I'm there, I'm going to be mindful and respectful of the rules of their house. Consequently, all Team Robins members are reminded to exercise certain protocols during Reveille and Retreat; see below for helpful information.

When Reveille plays in the morning, no action is required at

Robins, as the flag is displayed at the installation headquarters (Bldg. 905 at Robins Parkway and Ninth Street) 24 hours a day with proper illumination during the hours of darkness.

However, if the flag is being raised or lowered, or "To the Colors" or national anthem is being played, military members who are outside and in uniform should face the flag (if visible) or face the music, stand at attention, and salute on the first note of the music (or if no music, when you see the flag first being raised or lowered). You should drop your salute after the flag has been fully raised or lowered, or the last note has played.

During the playing of Sound Retreat, which precedes the lowering of the flag and the national anthem or To the Colors, military members should stand at parade rest. Civilians who are outside should face the flag (if visible) or face the music, stand, and place their right hand over their heart on the first note of the music (or if no music, when you see the flag first being raised or lowered).

If in a vehicle during Reveille (if the flag is being raised) or Retreat, pull the car to the side of the road and stop until the last note of the music has played or the flag is fully raised or lowered.

All sporting or physical training activities will stop during Reveille (if the flag is being raised) and Retreat, with proper honors to the flag being shown.

If a base flies the flag a continuous 24 hours and Reveille or Retreat is played with no action with the flag, or no playing of the National Anthem or "To the Colors," you are not required to stop and salute.

Changes to federal intern program

In late December, President Obama issued an executive order revoking the Federal Career Intern Program. However, the decision does not impact anyone working under the program at Robins.

Those in the program have been converted to career conditional status and will keep the same pay, although those who have worked less than one year of their two-year appointment will still have to complete their one-year probationary period.

The decision to revoke the Federal Career Intern Program included the creation of the Pathways Program, which includes the Internship Program, Recent Graduates Program, and the Presidential Management Fellows Program.

The order also replaces the Student Career Experience Program, which encompasses cooperative education programs, with the Student Intern Program.

According to officials, Student Career Experience Program employees will not see a loss in pay or benefits with the change.

Also, agencies can continue to hire under the coop program until a date for that program transition is announced.

Fire prevention is everyone's business

The Air Force has experienced several fires recently due to the failure or overloading of power strips, surge protectors and extension cords.

All of these devices are commonplace today in work areas.

What is the difference between a power strip and surge protector?

A power strip is a way for multiple pieces of electrical equipment to share a single electrical outlet. It is generally a series of electrical outlets contained in an electrically-shielded case, which is connected to a wall outlet with a single cable.

A surge protector is also a series of electrical outlets contained in an electrically-shielded case. However, it's used to protect equipment from surges in electricity by trapping excess voltage coming through a wall outlet. Such surges can be caused by natural phenomena, such as lightning, or by electrical appliances.

In the work area, fire prevention is everyone's

- All surge protectors or power strips must be from a nationally-recognized testing institute.
 - tionally-recognized testing institute.
 Review the manufacturer's instructions prior to use.
- Heavy-draw appliances such as air conditioners, dryers, electric stoves, space heaters, refrigerators and microwave ovens should not be used with surge protectors or power strips.
- Use only surge protectors or power strips with an internal circuit breaker. Also, make sure your surge protector has an indicator light which tells you if its protection components are functioning.
 - Do not daisy chain surge protectors or power strips.
- Do not place surge protectors or power strips where they will be covered with carpet, furniture, or anything else which will limit or prevent adequate air circulation.
- Never use a three- to two-prong adapter to power a surge protector or power strip; they should always have a three-prong, grounded plug or a polarized plug (a plug with one of the blades being larger than the other).
- Visually inspect all surge protectors or power strips on a regular basis to ensure they are not damaged or showing signs of wear or damage, or hot to the touch. During the visual inspection, ensure the plug is fully engaged in the respective outlet. If the unit is hot, immediately remove it from service and notify your supervisor to have the unit checked for overloading.
- If possible, unplug or turn off the power switch on surge protectors and power strips when not in use.
